This Confirmation for Studying Agreement of King Mongkut's University of Technology Thonburi is made between King Mongkut's University of Technology Thonburi (the first party) and Mr./Mrs./Miss (1) ID number..... The Promisor is selected to study at King Mongkut's University of Technology Thonburi and shall enter into the agreement with King Mongkut's University of Technology Thonburi with an attachment of the confirmation for studying fee slip. Both parties hereto agree as follows:

Clause 1 The Promisor agrees to study at King Mongkut's University of Technology Thonburi and should not apply for other TCAS Higher Education Institutions. However, the Promisor will be able to apply for other TCAS Higher Education Institutions as desired only after renouncing the right to study under the terms and conditions of the University and the Council of University Presidents of Thailand (CUPT).

Clause 2 The Promisor shall pay the confirmation for studying fee in accordance with the resolution of the Academic Council at its meeting No. 7/2551 (July 28, 2008) regarding payment of confirmation for studying fee for students selected by the University in the amount of..... Baht (.....) in order to confirm his/her intention to study at King Mongkut's University of Technology Thonburi. In the case where the Promisor fails to pay the confirmation for studying fee, the Promisor agrees that King Mongkut's University of Technology Thonburi may immediately deny his/her admission to the University.

In the case where the Promisor renounces his/her right to study according to Clause 1, the Promisor agrees that the fee mentioned in Clause 2 may be confiscated by the University, or in the case where the Promisor fails to study in a specified study period, it shall also be considered that the Promisor renounces his/her right to study and agrees that the fee mentioned in Clause 2 may be confiscated by the University.

Clause 3 The Promisor agrees to comply with any regulations, rules, announcements, orders or resolutions of King Mongkut’s University of Technology Thonburi that come into force on the date on which the Promisor signs this Agreement and that will enter into force on a future date. Moreover, the Promisor agrees to consider all these regulations, rules, announcements, orders or resolutions as part of this Agreement.

Clause 4 If the Promisor fails to comply with any one or more of the provisions of this Agreement, the Promisor agrees that King Mongkut’s University of Technology Thonburi may deny his/her admission or remove his/her name from being a student of King Mongkut’s University of Technology Thonburi immediately.
